(a) Selection of eminent poets from Haryana and arrangements for the visit of selected ones to Telangana State for poetical recitation on Haryana Folk Art & Culture at Hyderabad and the local arrangements will be made Telangana State.

(b) Will invite eminent poets from Telangana in consultation with Mr. Sumeet Singh, Executive Director, Telangana State Tourism Development Corporation. It was also proposed that the Literary Exchange Program may be held at Chandigarh/Rohtak.

3. Coins of Deccan Photo Exhibition / Raag Chitramala:- It was approved that the it will be held at Chandigarh Art Gallery, Chandigarh in August, 2018. Art & Culture Affairs Department, Haryana, in consultation with Haryana Archaeology & Museum Department, will organize the event.

4. Cuisine of Telangana:- It was approved that it will be held at Pinjore Garden during Mango Mela. Haryana Tourism Corporation in consultation with Mr. Sumeet Singh, Executive Director, Telangana State Tourism Development Corporation will organize the event.

5. National Integration Camp under NSS activity :- It was approved that Telangana State will organize National Integration Camp for a duration of seven days as per the NSS manual instructions in January, 2019 in which 50 NSS volunteer will participate from Haryana.

6. Regarding holding of Telangana Food Festival /Cultural Program/Art & Craft Mela /Display of Telangana Tourism, it was

approved that the said activities may be organized during **Gita Jayanti Mahotsav** by Haryana Tourism Department & Art & Culture Affairs Department, Haryana in consultation with Kurukshetra Development Board.

7. Regarding sports activity under Ek Bharat Shreshtha Bharat Program in the games of Football, Badminton & Kabbadi etc, it was informed that Higher Education Department, Haryana holds inter-college state championship in the said games and State Level Team will be selected which will be sent to Telangana for inter-state college tournaments in **February, 2019**. The above said activities may be organized jointly by Department of Higher Education, Haryana and Department of Sports & Youth Affairs Haryana and incurred expenditure on Sports Activities will be shared by the both Departments of Higher Education and Sports & Youth Affairs, Haryana.

It was also decided that expenditure on accommodation/boarding & lodging, hiring of venue, equipments related to event, catering & transportation etc. shall be borne by concerned department of the host State.

During deliberations, it was also pointed out that since Higher Education Department, Haryana is the nodal Department for coordination and monitoring the activities only under Ek Bharat Shreshtha Bharat Program. However the expenditure will be borne by individual department who have been asked to organized concerned activity. The officials and participants are to be granted a status of official guests so that required facilities could be extended to the officials and participants.


