- iv) Land acquisition of Ancient Site Banawali.

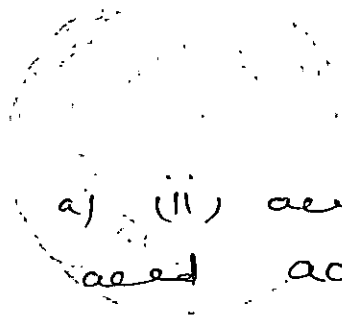

As per orders of worthy ACS (A&M) on NP 1 the comments of the Department are as follows:-

Archaeological Survey of India, Ministry of Culture, GOI

Agenda No 1.

(1) Transfer of Pili Kothi to Archaeological Survey of India Chandigarh Circle
An ancient building located within 50 meter from Centrally Protected Monument namely Firozshah Palace and Tehkhane in district Hissar under the ownership of State Government. Several time complaints have been received from locals for protection of this building. Therefore Archaeological Survey of India has requested several times to transfer this building to the ASI. But no satisfactory reply has been received till date.

Comments of the Archaeology Department, Haryana.

Originally Pili Kothi is located within the complex of Firozshah Palace but at present it is not under the protected area. So ASI wants to protect this ancient building and add to the same complex. ASI, Chandigarh Circle asked to State Government to hand over the land ASI.

As per information received from DC Office Hissar on today (19.2.2018) that the required land is 6 acre 15 marle which is at present under the control of Animal Husbandry & Dairy Department. A letter has been issued to said department by Chief superintendent, State livestock Farm Hisar on 3.8.17 but reply is still pending (Copy attached) ✓

Firoz Shah's Palace is located in opposite to the main bus stand of Hisar city and near the Lat Ki Masjid

19164 Dt. 17-07-1923 11078 Dt. 09-04-1924

Period -: 1351-88 AD

The edifice known as Firoz Shah's Palace and tahkhana was built by Firoz Shah Tughlaq, the Sultan of Delhi (1351-1388 AD). The palace is built of rubble masonry covered with thick lime plaster. Its arches are supported on sandstone carved pillars possibly belonging to some Hindu temples. The palace complex consists of an open courtyard surrounded by two and three-storied structures. A passage with steps leading to the terrace is embedded in the massive western wall of the palace. This passage was most possibly meant for guarding the roofs of the palace. It has several bastions with hollow cores and has a pillared hall connected with other rooms and cells of the palace. The red sandstone structures on the eastern side of the palace and the lotus tank on the terrace, however, are of much later origin.

ii) Land transfer of horse stable

Horse stable and adjacent land has not been transferred to the ASI, Chandigarh. Which is under control of Local Municipal Corporation of Narnaul, District Mahendergarh, Haryana.

iii) Approach way for the Centrally Protected Monument, Tomb of Shah Qull Khan, Narnaul, District Mahendergarh

There is a Centrally Protected Monument namely "Tomb of Shah Qull Khan". Several visitors come to the visit to the monument throughout the year. But there is no pathway/ approach way to the monument. A field lies between the monument and road so the field owner creates the hindrance to visitors as well as ASI official also to visit the same.

Horse Stable

ASI, Chandigarh Circle wants to take Horse Stable under their protection which is in under process.

Shah Quli Khan's Tomb with adjacent land

Notification No - F.4-14/62/C.3- Dt. 1-11-1962 F.4-14/62/C-I Dt. 2-3-1963

Located in Purani Mandi of Narnaul City.

Period -: 1574-75 AD

This beautiful tomb was built by Shah Quil Khan himself in 1574-75 AD. Shah Quil Khan was the Governor of Narnaul during the reign of Mughal emperor Akbar (1556-1605 AD). He built this tomb in memory of his father but after his death, his mortal remains were also buried here. Situated on a high octagonal platform approachable from south, the tomb is built in grey stone mixed with red sandstone presenting a remarkable appearance. Both the interior and exterior of the tomb are octagonal in shape having a narrow passage supported on projecting running all along the base of the arched openings and recesses. The interior of the tomb is sub-divided into two storeys.

ASI, Chandigarh Circle wants to take the land in between the monument and road.

This site is located 15 kms north - west of Fatehabad city at village Banawali, on the dry bed of ancient river Sarasvati.

The excavations have yielded three-fold culture sequence: Pre-Harappan (Early-Harappan), Harappan and Bara (post Harappan). This site was excavated by Dr. R.S.Bhist of Archaeological Survey of India.

The SA of ASI Chandigarh contacted district administration at Fatehabad about a week back. He met DRO (district revenue officer) and collected the jama- bandi (revenue papers showing the ownership, title, possession, share holding etc.) along with market rate and collector rate of the area in question. Till now no legal process for acquisition has started. For further details, Chandigarh office may be contacted.

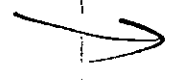

The PUC received from Shikha Jain, Director DRONAH the research proposal of challenges faced in Heritage Management in India and Policy Imperatives. It focuses on preparing a collective heritage database sourced from various departments in centre, states and UTs with a purpose to present a comprehensive report reviewing gaps in heritage management in order to formulate a phased action plan to overcome the identified challenges. The State of Haryana may have protected and unprotected historic sites under various state departments such as:

1. Directorate of Archaeology and Museums, Haryana
2. Department of Town and Country Planning (Local bodies with historic city cores such as Ambala, Narnaul, Rewari, Farukhnagar, Hisar, Kurukshetra, Pehowa and several others)
3. PWD with colonial period guest houses and other structures
4. Department of Forest including historic structures within forest areas, dak bungalows etc.
5. Other such as Department of Higher Education with historic university campuses or school buildings of significance (if any).

We request your good office to provide support in sourcing information related to protected and unprotected built heritage sites/structures listed under various Departments in Haryana, to be included for the above mentioned database. Following information will be required.

1. A district wise list of built heritage sites under each department (protected and unprotected) with photographs.
2. List of acts, rules, policies, initiatives etc. effective on the heritage structures/sites for management and protection (if any).
3. Status of the listed sites and information about conservation work (if any) carried out.
4. Any additional information related to the listed sites deemed relevant to the research.

We request you to assign a nodal person in your office for coordinating on sourcing this information. A representative from our office will be following up in this regard for the requested information. I also look forward to meeting you personally during my visit to Chandigarh as per your convenience and availability. We will look forward to your support in contributing to this national heritage database for NITI Aayog.
