




Sub: - Regarding appointment of Nodal Officer to deal with the references received from National Human Rights Commission and for ensuring that reply reaches the Commission in time.

Sir,

I am directed to refer to the subject noted above and to say that it has been felt that in a large number of cases of references received from National Human Rights Commission reply is not sent in time to the National Human Rights Commission by the quarter concerned and the Commission has to write to Chief Secy. to Govt. Haryana for getting the reply sent.

2. The matter has been considered by the Government and it has been decided as under: -

- i) At State level Under Secretary Home Department will work as a Nodal Officer for this work and Research Officer, Minority Community Cell will assist him.
- ii) All the Administrative Secretaries, Heads of Deptts. Divisional Commissioners, IG ranges, DCs and SPs will appoint Nodal Officers in their respective offices for dealing with human rights violation cases and they should be made responsible for timely action on the cases received from NHRC.
- iii) All the authorities should have a quarterly review of the cases and send detailed report to Government.
- iv) At Government level also Secretary Home will also

review periodically the progress of the disposal of cases.

v) This subject may also be made an item on permanent basis for discussion in DCs/SPs conference.

vi) The Nodal Officer/Research Officer at State level will reconcile the disposal of cases with the NHRC so that exact position of cases pending may be known.

Accordingly, you are requested to appoint a gazetted officer of your department as Nodal Officer in all offices for dealing with references received from NHRC regarding Human Rights violation cases. The Nodal Officers should ensure timely action in all matters received from NHRC and sending a quarterly status report of replies sent/pending to the Govt. in Home Department for monitoring cases at state level.
